

"Gold Class Trader" Promotion

Terms and Conditions

ELIGIBILITY FOR THE PROMOTION

- 1. Promotion is eligible to both existing/new Phillip Nova Pte Ltd (PNPL) clients.
- 2. For non-clients, please register for a Multi Asset Account here.
- 3. PNPL reserves the right to refuse incentive issuance to **Non-Eligible Clients**. The following are not eligible for participation in the **Gold Class Trader Promotion**:
 - a) A sole proprietorship, company, partnership and any entity that constitute as Corporate;
 - b) Any PNPL's Employees and/or its Immediate Family Members;
 - c) All agencies and/or service providers engaged by PNPL (including but not limited to advertising agencies, promotions agencies, printing companies, event management agencies and any persons assisting or who are involved in the Campaign) and their Employees and Immediate Family Members.

PROMO MECHANISM

- 4. The promotional period is from 3rd March 2025 to 30th June 2025.
- 5. Clients who place trades in any two or more different Gold assets of any lot size via Phillip Nova 2.0 within the promotional period ("Eligible Clients") will receive a pair of Golden Village Gold Class All Days Gift Vouchers.

Gold assets include Gold Futures, Gold Options, OTCD SPOT Gold and Gold ETF.

Example 1 Trade any 1 lot of **Gold Futures** and trade any 1 lot of **Gold Option** within the same month.

Example 2 Trade any 1 lot of **Gold ETF** and trade 1 lot of **SPOT Gold** within the same month.

- 6. Each Eligible Client will be eligible for 1 pair of Golden Village Gold Class All Days Gift Vouchers ("Reward") over the entire campaign.
- 7. No platform fee will be charged on Phillip Nova 2.0.

TERMS & CONDITIONS FOR VOUCHER REDEMPTION

8. PNPL will notify the Eligible Clients of the collection of the Reward via email/phone call/SMS, within fourteen (14) calendar days after the calendar month of its



participation.

- 9. For Eligible Clients residing overseas, PNPL will credit <u>\$\$80</u> into their Multi Asset Account.
- 10. The voucher redemption is available to clients who fulfilled the eligibility criteria set by **Phillip Nova Pte Ltd (PNPL)**.
- 11. Eligible clients may receive either a **physical voucher or an e-voucher**, depending on the nature of the promotion. The type of voucher issued will be at the sole discretion of **PNPL**.
- 12. Vouchers (both e-vouchers and physical vouchers) are valid for redemption only at participating merchants, as specified in the voucher details.
- 13. Each voucher is subject to the terms and conditions set by the respective merchant and must be used before the expiry date specified by the merchant. **PNPL** is not responsible for any restrictions imposed by the merchant on the use of the voucher.

USE OF VOUCHERS

- 14. Vouchers are non-transferable, non-exchangeable, and cannot be converted into cash, store credit, or any other form of compensation.
- 15. The voucher must be used in accordance with the terms set by the participating merchants. Any restrictions on the use of the voucher (e.g., minimum spend, eligible products/services) will be stated in the voucher details.
- 16. The voucher cannot be used in conjunction with other discounts, promotions, or vouchers unless otherwise specified.
- 17. For **physical vouchers**, any lost, stolen, or damaged vouchers will not be replaced under any circumstances.

NON-RECEIPT & EXPIRY

- 18. E-vouchers will be sent to the recipient via their registered email or mobile number. PNPL is not responsible for any issues arising from incorrect, outdated, or inaccessible contact details provided by the client.
- 19. **Physical vouchers** must be collected in person, as specified in the redemption details. **PNPL** will not be responsible for any uncollected vouchers after the designated collection period.
- 20. If the recipient does not receive the e-voucher, they must notify **PNPL** within 7 days from the date of issuance. Requests made after this period will not be entertained.
- 21. Vouchers that are lost, deleted, expired, or otherwise unredeemed will not be reissued or extended under any circumstances.

FRAUD & MISUSE



- 22. Any attempt to duplicate, resell, or misuse the voucher will result in immediate disqualification from the redemption program. **PNPL** reserves the right to take legal action where necessary.
- 23. In case of any suspected fraudulent activity, **PNPL** may suspend or cancel the voucher without prior notice.

GENERAL TERMS

- 24. **PNPL** reserves the right to amend, vary, or cancel these terms and conditions at its sole discretion without prior notice.
- 25. By participating in the redemption program, the client agrees to abide by these terms and conditions.
